

## OUR CONTRIBUTORS

JÁNOS BARTA teaches in the Department of Medieval and Early Modern History at the University of Debrecen (Kossuth Lajos Tudományegyetem) in Debrecen, Hungary. He has published widely on the history of early modern Hungary and the Habsburg Empire. His books include a monograph on the Empress Maria Theresa, another one on the Emperor Joseph II, and still another on the enlightened absolutist agrarian policies in the Habsburg and Hohenzollern monarchies. He also published a volume in the series *Magyar História* (produced in collaboration with the Institute of History, Hungarian Academy of Sciences): *A kétféjű sas árnyékában: az abszolutizmustól a felvilágosodásig, 1711–1780* [In the shadow of the two-headed eagle: from absolutism to the enlightenment] (Budapest: Gondolat, 1984).

BÉLA BODÓ teaches Central European social and political history at the University of South Florida, in Tampa. Previously he had taught at Oklahoma State University in Stillwater, and the University of Windsor in Windsor, Ontario. He studied at the University of Toronto and at Toronto's York University, where he earned his M. A. and Ph. D. degrees. He is the author of the recently released *Tiszazug: A Social History of a Murder Epidemic*, published in Columbia University Press' East European Monographs series. His articles have appeared in the *Journal of Family Studies*, *Yad Vashem Studies*, and the *Bulletin of the History of Medicine*.

NÁNDOR DREISZIGER has been the editor (for history and related disciplines) of this journal since the 1974. He teaches European and North American history at the Royal Military College of Canada. He is the principal author of *Struggle and Hope: The Hungarian-Canadian Experience* (McClelland & Stewart, 1982), and editor of such volumes as *Mobilization for Total War* and *Ethnic Armies* (Wilfrid Laurier U. P., 1981 and

1990) as well as of *Hungary in the Age of Total War, 1938–1948* (Columbia University Press/East European Monographs, 1998). Among the journals that featured his articles are the *Journal of Modern History*, *Journal of Canadian Studies*, *Historical Papers* (the yearbook of the Canadian Historical Association), *New York History*, *Canadian Slavonic Papers*, *Canadian Review of Studies in Nationalism*, and most recently, the *Hungarian Journal of English and American Studies*.

ZOLTÁN KOSZTOLNYIK is Professor of History at Texas A & M University in College Station, Texas. He is the author of the monographs: *Five Eleven Century Hungarian Kings; From Coloman the Learned to Béla III (1105-1196): Hungarian Domestic Policies and their Impact upon Foreign Affairs; Hungary in the Thirteenth Century; and Hungary under the Early Árpáds, 890s to 1630*; all released in Columbia University Press' East European Monographs series. His articles on the history of medieval Hungary have appeared in journals such as the *Catholic Historical Review*, *Studies in Medieval Culture*, *Ungarn Jahrbuch*, *Church History*, *Századok* [Centuries] (Budapest), *Acta historica Szegediensis*, *East European Quarterly*, and *Essays in Church History of Hungary*. He has also published over a dozen studies in various essay collections.

GÉZA PÁLFFY is a research fellow with the Historical Institute of the Hungarian Academy of Sciences and is deputy Secretary-General of the Hungarian Historical Society. He has taught at Janus Pannonius University in Pécs and Eötvös Loránd University in Budapest, Hungary. His research interest is in the history of Hungary and the Habsburg Empire in the early modern age. His books, catalogues, and papers (published in Hungarian and German) have dealt with such subjects as the defence of the Habsburg Monarchy in Hungary against the Ottomans in the 16<sup>th</sup> and 17<sup>th</sup> centuries, military jurisdiction on the military frontier of the Habsburg Empire, military cartography related to the Hungarian and Croatian-Slavonian military border, Croatian migration to Austria and Hungary in the 16<sup>th</sup> century, history of the Court in Vienna and the history of the Hungarian nobility. His most recent book is a history of 16<sup>th</sup> century Hungary: *A tizenhatodik század története* (Budapest, 2001).

PETER PASTOR is Professor of History at Montclair State University in Upper Montclair, New Jersey. He is the author of *Hungary between Wilson and Lenin: The Hungarian Revolution of 1918-1919 and the Big Three* (East European Monographs, 1976) and of numerous papers in edited volumes — as well as numerous articles in journals including the *Slavic Review* — mainly on the subjects of the First World War in East Central and Eastern Europe, and Hungarian-Russian relations. He has edited and co-edited several volumes in Columbia University Press' East European Monographs series, as well as elsewhere. He is a co-founder — and former or current chief executive officer — of the American Association for the Study of Hungarian History and of the Center for Hungarian Studies and Publications of Wayne, New Jersey. Professor Pastor was one of the very first contributors of our journal.

LÁSZLÓ VESZPRÉMY is the Curator of the Library and Map Collection of Military History at Hungary's Institute of Military History. He is also a visiting professor at Budapest's Central European University. He is a former research fellow of the Institute of History, Hungarian Academy of Sciences. Among the works he translated and edited is Simon Kézai's thirteenth century chronicle *Gesta Hungarorum* (Budapest: Central European University Press, 1999). His other publications include a catalogue of Latin Codex fragments in Hungary, as well as papers, articles and edited volumes dealing mainly with the subject of medieval Hungary.
